APPROVING A SPECIFIED PROJECT OF THE HOUSING FINANCE AGENCY (USDA 515 Preservation Program Subsidy Loan - Walden Park)

WHEREAS, the New York State Public Authorities Control Board ("PACB"), created pursuant to Chapter 38, Laws of 1976, as amended, is empowered by section 51 of the Public Authorities Law to receive applications from designated public benefit corporations, including the Housing Finance Agency ("HFA"), for approval of the acquisition, rehabilitation, construction or financing of any project proposed by any such public benefit corporation; and

WHEREAS, the PACB has duly received an application from HFA for approval of a USDA 515 Preservation Program subsidy loan in the amount of \$3,123,784 (the "Subsidy Loan") to finance the upgrades to five one-story buildings, constructed under the U.S. Department of Agriculture 515 Rural Development Program in 1978 and located at 6113 Strauss Road, Lockport, Niagara County, where all the 61 apartments are set aside for senior residents with household incomes at or below 60% of the Area Median Income ("AMI") adjusted for family size for Niagara County, known as Walden Park (the "Project"); and

WHEREAS, HFA intends to provide the Subsidy Loan from USDA 515 Preservation Program funds or any funds legally available to
