PART L

Section 1. Section 56-0401 of the environmental conservation law, as added by chapter 413 of the laws of 1996, is amended to read as follows:

Of the moneys received by the state from the sale of bonds pursuant to the Clean Water/Clean Air Bond Act of 1996 to be used for solid waste projects, fifty million dollars (\$50,000,000) shall be available for disbursements for municipal landfill projects, excluding any landfill closure project in the city of New York; fifty million dollars (\$50,000,000) shall be available for disbursements for municipal recycling projects, of which twentyfive million dollars (\$25,000,000) shall be available for municipal recycling projects in the city of New York; and seventy-five million dollars (\$75,000,000) shall be available for disbursements for closure of Fresh Kills Landfill in the city of New York.

§2. This act shall take effect immediately."
