# DIVISION OF CRIMINAL JUSTICE SERVICES

### Administration Program

COUNCIL ON THE ARTS

### New York Institute for Cultural Education Program

The amendments clarify that the appropriations shall only be available upon enactment of a chapter of the laws of 2005 which establishes the New York Institute for Cultural Education.

## STATE EDUCATION DEPARTMENT

### Elementary, Middle, Secondary and Continuing Education Program

The amendment corrects the appropriation amount for the education of incarcerated youth. This correction does not affect appropriation totals.

### Cultural Education Program

The amendments clarify that a portion of the appropriations and reappropriations shall only be transferred to the Council on the Arts upon enactment of a chapter of the laws of 2005 which establishes the New York Institute for Cultural Education.

# Vocational and Educational Services for Individuals with Disabilities Program (VESID)

# DEPARTMENT OF FAMILY ASSISTANCE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE

## Temporary and Disability Assistance Program

The amendments restore language required by the State Social Services Law and clarify that the authorization for the transfer of moneys to the Department of Labor shall not be effective upon enactment of a chapter of the laws of 2005 which transfers the Welfare-to-Work program to the Office of Temporary and Disability Assistance.
