For the purpose of subdivision one of this section, generation of hazardous waste shall not include retrieval or creation of hazardous waste which must be disposed of (1) under an order of or agreement with the department pursuant to title thirteen or title fourteen of this article; or (2) under a contract with the department pursuant to title five of article fifty-six of this chapter; or (3)under a permit or order requiring corrective action pursuant to title nine of article 27 of this chapter, title 27 of article 71 of this chapter or the Resource Conservation and Recovery Act (42 U.S.C. 6901 et seq.); or (4)under an order with the department, the United States environmental protection agency or a court, related to a removal action pursuant to the Comprehensive Environmental Response,

Compensation and Liability Act (42 U.S.C. 9601 and seq.); or (5)under a contract or order with the department related to cleanup of a hazardous waste spill pursuant to article 12 of the Navigation Law or Title 10 of article 17."
