Notes:

(1) Payment schedule pursuant to the 2007-08 Enacted Budget requires the same amount and dates as the 2006-07 AIM program, except as follows:

- a. Buffalo, Rochester and Syracuse each receive \$3.4 million on or before June 30 instead of on or before March 30 (Part R of Chapter 56 of the Laws of 2004)
- b. Increases in aid for cities under the AIM program are paid on or before December 15 for cities with fiscal years beginning in January and on or before March 15 for all other cities.
- c. Increases in aid for towns and villages under AIM program are paid in September

(2) Payment schedule does not include the Shared Municipal Services Incentive (SMSI) program, which is subject to a Department of State grant application and award process.
