

**PUBLIC PROTECTION AND GENERAL GOVERNMENT BUDGET BILL

OFFICE OF GENERAL SERVICES

The amendment makes a technical correction.

INTEREST ON LAWYER ACCOUNT

The amendment adds a \$1,000,000 Miscellaneous Special Revenue Legal Services Assistant Account, Aid to Localities appropriation to provide additional resources for grants for civil legal services.

DIVISION OF STATE POLICE

The amendment adds an appropriation for a Federal Internet Crimes against Children grant that has been renewed for FFY 09-10 in the amount of \$700,000.

**Amendments to the
EDUCATION, LABOR AND FAMILY ASSISTANCE BUDGET BILL
(Senate 53 and Assembly 153)**

CITY UNIVERSITY OF NEW YORK

General Maintenance and Improvements Capital Construction Program (CCP)

The amendment adds language to an existing capital projects re-appropriation to support costs of a joint project involving a City College of New York - New Science Facility and a University-wide Advanced Science Research Center. The existing appropriation language limits support to the University-wide aspects of the joint project, which is co-located on the CCNY campus, and this amendment clarifies the intent to use this appropriation to support related project costs at either campus/facility.

STATE EDUCATION DEPARTMENT

Elementary, Middle, Secondary and Continuing Education Program

The amendments make technical corrections to the appropriation language for the charter school stimulus fund to clarify that funds can be transferred to the Charter School Institute of the State University of New York and to correct the total appropriation amount for state operations and aid to localities.

OFFICE OF CHILDREN AND FAMILY SERVICES

The amendment makes a technical correction.

OFFICE OF TEMPORARY DISABILITY ASSISTANCE

The amendments make technical corrections.

HIGHER EDUCATION SERVICES CORPORATION

Student Grant and Award Programs

The amendment increases by \$350,000 an appropriation for scholarship and loan forgiveness programs administered by HESC, to support costs related to the new "Say Yes to Education" SUNY/CUNY Scholarship program. This scholarship program will provide eligible graduates of the Syracuse City School District with support for the cost of tuition and fees at SUNY and CUNY institutions.

Division of Guaranteed Loan Program

The amendment makes a technical correction.

DEPARTMENT OF LABOR

Unemployment Insurance Program

The amendments increase the Special Revenue-Other appropriation for the Interest Assessment Account by \$10 million, reflecting an increased estimate of the potential interest payment to be made for Federal loans to the UI Trust Fund.

STATE UNIVERSITY OF NEW YORK

The amendments make various technical corrections, including adjusting appropriation amounts for self-supporting special revenue accounts to fully support the cost of collective bargaining agreements and reappropriating special revenue account funds to cover ongoing contract costs.

General Maintenance and Improvements Capital Construction Program (CCP)

The amendment makes technical corrections, to reflect the Executive intent to amend an existing reappropriation to support a new project at Monroe Community College, not Mohawk Valley Community College.

- Corrects appropriation for the Public Management Leaders of Tomorrow to allow a suballocation to the University at Albany School of Public Health.

Medical Assistance Program

- Increases long term care appropriation to reflect reestimate of General Fund savings (\$11 million) associated with 0.7 percent assessment on certain Medicaid home care categories.
- Reduces non-institutional appropriations by \$3.5 million to reflect revised 2009-10 spending estimates for an investment to streamline Medicaid eligibility requirements.
- Reduces pharmacy appropriations by \$500,000 to reflect savings associated with Article VII provisions that prohibit pharmaceutical companies from providing gifts to prescribers.
- Adds reappropriation for Hospital Workforce Recruitment and Retention rate funding to account for delayed Federal State Plan Amendment approval.
