If every social service district that elected such option repeals its election and the commissioner of health certifies in writing to the commissioner of taxation and finance that every such social services district has repealed its election, then subdivisions (f) and (g) of section 1261 and subdivision (h) of section 1313 of the tax law shall be repealed and the phrase "or a tax revenue intercept amount calculated pursuant to subdivision (f) or (g) of section 1261 of the tax law" in section four of this act shall be deleted, effective the first day of the month next commencing at least 10 days after the date on which the commissioner of taxation and finance receives such written certification from the commissioner of health. At the same time that the commissioner of health makes such certification to the commissioner of taxation and finance that every county has repealed its election, the commissioner of health shall also notify the legislative bill drafting commission that every social service district that elected such option has repealed its election in order that the legislative bill drafting commission may maintain an accurate and timely data base of the official text of the laws of the state of New York in furtherance of effecting the provisions of section 44 of the legislative law and section 70-b of the public officers law."

(iii) Form of resolution.

Be it enacted by the (county) of (insert county's name) as follows:

Section one. The (county) of (insert county's name) hereby repeals its election in 2007 of the medical assistance reimbursement option and revenue intercept for Medicaid purposes described in section 2 of chapter 58 of the laws of 2005.
