A BUDGET BILL submitted by the Governor  
in accordance with Article VII of the Constitution

AN ACT to amend the public lands law, in relation to state aid on  
certain state leased or state-owned land (Part \_\_);

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 PART \_\_

2 Section 1. Paragraph 1 of subdivision 2-a of section 19-a of the  
3 public lands law, as amended by section 1 of part T of chapter 55 of the  
4 laws of 2013, is amended to read as follows:

5 (1) Notwithstanding any provision of this section to the contrary, in  
6 addition to state aid otherwise payable pursuant to this section, there  
7 shall be payable to any city located in a county in which there has been  
8 constructed a state office building project in accordance with the  
9 provisions of chapter one hundred fifty-two of the laws of nineteen  
10 hundred sixty-four, as amended, and pursuant to an agreement entitled  
11 the "South Mall contract" dated May eleventh, nineteen hundred sixty-  
12 five, state aid in accordance with the following schedule:
