

FY 2026 Executive Budget Amendments

**Amendments to Senate S.3005; Assembly A.3005
(PPGG Article VII Bill)**

The following technical amendments, as described, are made:

Part EE, relating transfers, temporary loans, and amendments to miscellaneous capital/debt provisions, including bond caps (Pages 78-82)

- Strikes "green loan energy fund" and insert "green energy loan fund" (Page 78).
- Adjusts transfer authorization from the general fund to the combined gifts, grants, and bequests fund, WB Hoyt Memorial account (20128) from \$621,850 to \$788,000 (Page 79).
- Strikes the transfer authorization from the miscellaneous special revenue fund, DOL fee and penalty account (21923) to the Training and Education Program on Occupation Safety and Health Fund, OSHA Inspection Account (21252) (Page 82).
- Strikes the transfer authorization from the miscellaneous special revenue fund, DOL fee and penalty account (21923), to the Training and Education Program on Occupation Safety and Health Fund, OSHA Training and Education account (21251) (Page 82).
- Adjusts transfer authorization from the miscellaneous special revenue fund, Public Work Enforcement account (21998), to the Training and Education Program on Occupation Safety and Health Fund, OSHA Training and Education account (21251) from \$5,000,000 to \$1,000,000 (Page 82).
- Adds the transfer authorization from the miscellaneous special revenue fund, Public Work Enforcement account (21998), to the Training and Education Program on Occupational Safety and Health Fund, OSHA Inspection Account (21252) (Page 82).

New Part FF, relating to modifying existing statutory language affecting the New York City Employees' Retirement System, (NYCERS), the New York City Teachers' Retirement System (NYCTRS) and the Board of Education Retirement System of the City of New York (BERS) Unfunded Accrued Liabilities (UAL), is added to:

- Amortize the UAL of the NYCERS, NYCTRS and BERS on an alternate schedule.
- Change the smoothing method used for investment gains and losses.
- Allow the Actuary to reset the UAL amortization schedule under certain scenarios.

New Part GG, relating to the Department of Corrections and Community Supervision (DOCCS) Body Worn Camera Program (Pages 4, 5 and 116), is added to:

- Establish DOCCS' Body Worn Camera Program in law.

New Part HH, relating to the State Commission of Correction (SCOC) (Pages 4, 5 and 116), is added to:

- Require SCOC to visit and conduct annual inspections of all Department of Corrections and Community Supervision (DOCCS) correctional facilities, jails, and Office of Children and Family Services (OCFS) secure facilities.

New Part II, relating to the Department of Corrections and Community Supervision correctional facilities (Pages 4, 5 and 116), is added to:

- Authorize the closure of up to five Department of Corrections and Community Supervision (DOCCS) correctional facilities within State Fiscal Year 2025-26.
