"Notwithstanding any other provision of law to the contrary, when required by the regulations of the department of health, an authorized agency approved by the office of children and family services to care for or board out children, may not provide limited health-related services to foster children either directly or through a contract arrangement, unless such authorized agency has obtained a license issued by the department of health in conjunction with the office of children and family services to provide such services, or unless such authorized agency is otherwise authorized to provide such services under a license issued pursuant to article 28 of the public health law or article 31 of the mental hygiene law; provided however, that such license shall not be issued unless it is determined that the equipment, personnel, rules, standards of care and services are fit and adequate, and that the health related services will be provided in the manner required under law; provided further, however, that such licenses may be revoked, suspended, limited, annulled or denied if such authorized agency is determined to have failed to comply with the required provisions of law; however, no such license shall be revoked, suspended, limited, annulled or denied without a hearing, but a license may be temporarily suspended or limited without a hearing for a period not in excess of 30 days upon written notice that the continuation of health-related services places the public health or safety of the recipients in imminent danger."
