Newburgh Enlarged City School District operates a centralized budget process where salaries are determined based on contractual agreements. As seen in Part B, we have buildings that have a higher level of staff with less than three years of experience. We are supporting school leaders with more local control for student support. The NECSD has developed an equity formula that allocates additional funds, beyond the core allocation to support the diverse student needs and program needs found in each school. We are in the process of developing our school leader capacity to determine the specific needs of the student population and then apply the funding to support evidence based programs and strategies to impact positive student outcomes.

The equity formula is used to determine the additional funding provided to schools based on the diverse student population in each school. Funding is provided based on the population of English Language Learners (ELLs), Students with Disabilities (SWDs), student enrollment, academic performance from the previous year, K-2 literacy priority, and poverty. The final allocation is based on NYSED Accountability Ratings. Schools considered to be FOCUS, by the NYSED receive \$50,000 to support improvement efforts. Schools in Good Standing will receive an additional \$5,000 in general funds to support time for collaboration by stakeholders in the school to analyze data and implement improvement efforts.

The equity formula starts with a \$12,000 base allocation. The student population is divided into K-5, 6-8 and 9-12 with corresponding per student allocations. The district has placed an emphasis on ELLs, Exceptional Learners, and K-2 readiness. The district will review the student enrollment after BEDS day and hold harmless the building with a decline in population and increase those who had an increase. This is the first year we are implementing this formula and we plan to make revisions when the year closes out after we have received feedback from our stakeholders.
